The lead agency will work with Chicago Task Force on Homeless Youth to identify a multi-level project governance structure similar to the governance of our other collaborative initiatives. We envision that this will include a smaller steering committee with representatives from key systems such as child welfare, juvenile probation, Youth Advisory Board members, advocates, youth service providers, the Coordinated Entry Lead Agency and the Collaborative Applicant. Work groups based on the work identified in the community’s project plan. Until the steering committee is formally approved, the Chicago Task Force on Homeless Youth will serve as the interim advisory body for this project.
